The Form must be sent to Il Ponte at least 24 hours before the auction starts - by fax to +39 02.36633096 or by sending an email in pdf format to pitteri@ponteonline.com (or to the email address of the relevant department).

If a bidder wishes to submit one or more bids in writing as the representative of a third party, he must present a proxy signed by the principal with an attached copy of the principal's identity document and tax code; if the principal is a company, the proxy must be signed by the legal representative thereof or by an agent with signing authority, whose identity document and tax code must be attached to the proxy. In any case, Il Ponte - Casa d'Aste Srl has the right to prevent the representative from participating in the auction when, at its sole discretion, it deems that the power of representation has not sufficiently been demonstrated.
